SOUTH JETTY UPDATE.

South Jetty contract is being contested, which means that it may go to court and push back project start date. Work plan and approved funding established to start near shore disposal site. Folkema noted that she attended Wyden's town hall, will plan to attend Merkleys. Daniels noted wants to bring up tonnage. Saindon noted that not able to attend, but wants feds to define special districts. During COVID funding issues arose with the definition of special districts. Discussion regarding loans and whether they were forgiven or not. Folkema noted would like to make the best use of the time available.

## ABANDONED/DERELICT VESSEL AND MOORAGE CONCERNS.

Saindon noted that TLT grants are active and are moving forward. OSMB Kayak launch is being revisited by OSMB. RAISE grant is coming up and due at the end of February. MARAD is releasing Ports Infrastructure grant. Trails grants are coming up. Need to address rip rap concerns in Bay City. Saindon noted grants for electric vehicle charging stations keep running across his desk, lots of funds available.

## AUDIT UPDATE.

Saindon noted would like action on this item tonight. All years have been reviewed and request for an update of FY 2022 was made.

Motion Daniels, second by Browning to approve audits for FY 2020, FY 2021 and FY 2022 as amended. Motion carried 3 - 0.

Saindon noted that involved in the city vetting board for new city manager.

## STAFF REPORTS

Coon noted that the county has asked for an updated district information list, requesting current addresses for commissioners. Some have been received already, Looking for Daniels and Perez.

Coon noted brought a report on the inventory lists so that the commission might be able to see where exactly the inventory fund is and how it is going.

Saindon noted working on getting Con. Bonamici to the port.

Saindon noted that working on getting together with TEP to review project and then present at the next meeting.

Working with Dan Haag and Liane Welch on a trails plan. STIA has trail rights to the section. Questions were presented about liabilities.

Dredging – on the schedule for the next in-water work window, November 2023-February 2024. Will need to make some financial decisions in June or July.

Saindon noted a county wide drill at the red building. Will start laying ground working with a fire districts. All fire departments are sending people to EMT school and preparing to do basic transport.
